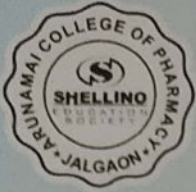

7.1.2 The Institution has facilities for energy conservation measures

Guidelines for energy conservation implemented at Arunamai College of Pharmacy.

1. To carry out a widespread energy audit of the college to identify areas where energy consumption can be reduced.
2. To develop a plan to promote the use of LED light energy sources identifying suitable locations for assessing the feasibility area.
3. Promote students, faculty, and staff to adopt energy efficient practices such as turning off lights and electronics when not in use, using public transportation or carpooling to reduce transportation-related emissions, and using reusable water bottles and coffee cups.
4. Replace traditional light bulbs and tube lights with energy-efficient LED bulbs and tube lights. This will reduce energy consumption and lower electricity bills.
5. Replace old and inefficient appliance such as air conditioners, refrigerators, and water heaters with newer, more energy-efficient models. This will also reduce energy consumption and lower electricity bills.
6. Develop a waste management plan that includes recycling and composting. This will help reduce the amount of waste sent to landfills and also reduce greenhouse gas emission associated with waste disposal.
7. Conduct regular energy audits and review progress on energy conservation measures to ensure that the college is meeting its energy conservation goals.





Geotag Image: Groundwater Recharge by Rainwater pipeline

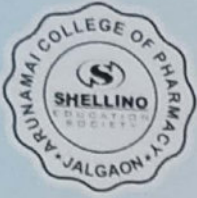


Geotag Image: Rainwater Recharge by pipeline

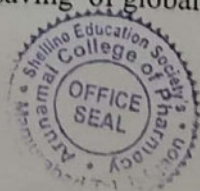
ACOP GREEN CAMPUS POLICY



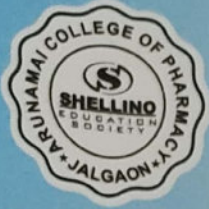
OBJECTIVE OF THE POLICY:

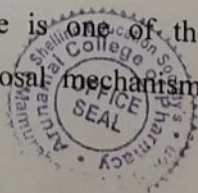


Waste Management:

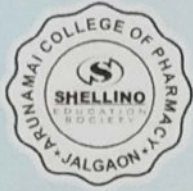


Medicinal Plant: Areca Nut & Anjir Plant

In continuation to this office letter number F. 6-1/2021(SCT) dated 19.03.2021 & 24.03.2021, UGC is continuously monitoring the progress of implementation of Policy for Persons with Disabilities in educational institutions. You are requested to follow the measures mentioned below :

- 1) To create special facilities such as ramps, rails and special toilets, and make other necessary changes to suit the special needs of differently-abled students such as special aids and appliances for their daily functioning.
- 2) To provide special learning and assistive devices to help differently-abled students enrolled for higher education. Availability of devices such as computers with screen reading software, low-vision aids and scanners in the institutes would enrich the educational experiences and facility of Readers to differently abled students.
- 3) Setting up Special Guidance Centres in Universities and Educational Institutes for differently-abled students.

The above instructions should also be circulated to all the constituent and affiliated colleges of your university for follow-up action please.

Reservations in Higher Educational Institutions


"32(1) : All Govt. Institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than five percent. seats for persons with benchmark disabilities.

32(2) : The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions of higher education."

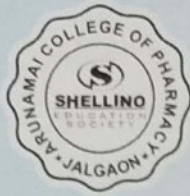
