### ANTI-DISCRIMINATION COMMITTEE (ADC)

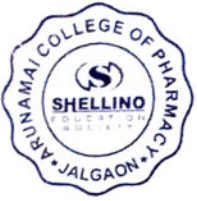
#### **Introduction:**
