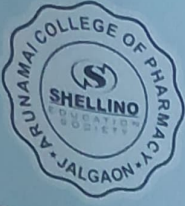
Objectives

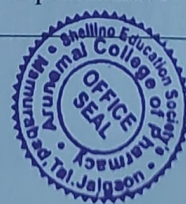
Following points were discussed in the meeting.
